SECUREDROP IS AN OPEN-SOURCE WHISTLEBLOWER SUBMISSION SYSTEM AND SOFTWARE PROJECT THAT FREEDOM OF THE PRESS FOUNDATION DEVELOPS, MAINTAINS, AND HELPS NEWS ORGANIZATIONS INSTALL. SECUREDROP COMBINES A VARIETY OF OPEN-SOURCE SECURE COMMUNICATIONS TOOLS AND PRACTICES INTO ONE EASIER-TO-USE PACKAGE THAT ALLOWS JOURNALISTS AND SOURCES TO COMMUNICATE SAFELY AND SECURELY ONLINE. SECUREDROP IS CURRENTLY USED AT OVER 70 MAJOR NEWS ORGANIZATIONS WORLDWIDE, INCLUDING THE NEW YORK TIMES, WASHINGTON POST, ASSOCIATED PRESS, USA TODAY, PROPUBLICA, THE NEW YORKER, THE GUARDIAN, AND THE INTERCEPT. IT IS ONE OF THE PREMIERE TOOLS ADVOCATED FOR JOURNALISTS WHO WANT TO IMPROVE THEIR DIGITAL SECURITY.

THE US PRESS FREEDOM TRACKER - IN 2017, FREEDOM OF THE PRESS FOUNDATION LAUNCHED THE US PRESS FREEDOM TRACKER, A NEWS SITE AND DATABASE THAT ATTEMPTS TO COMPREHENSIVELY DOCUMENT VIRTUALLY EVERY PRESS FREEDOM VIOLATION IN THE UNITED STATES, INCLUDING THE NUMBER OF JOURNALISTS ARRESTED, STOPPED AT THE BORDER, SUBPOENAED, PHYSICALLY ATTACKED, SURVEILLED, AND MORE.
