FREEDOM OF THE PRESS FOUNDATION DEVELOPS, MAINTAINS, AND HELPS NEWS ORGANIZATIONS INSTALL THE SOFTWARE. SECUREDROP COMBINES A VARIETY OF OPEN-SOURCE SECURE COMMUNICATIONS TOOLS AND PRACTICES INTO ONE EASIER-TO-USE PACKAGE THAT ALLOWS JOURNALISTS AND SOURCES TO COMMUNICATE SAFELY AND SECURELY ONLINE. SECUREDROP IS CURRENTLY USED AT OVER 60 MAJOR NEWS ORGANIZATIONS WORLDWIDE, INCLUDING THE NEW YORK TIMES, WASHINGTON POST, CNN, THE GUARDIAN, THE ECONOMIST, AND THE INTERCEPT.

FOR EXAMPLE, THE FORMER ARTICLE PROVIDED FOR STAGGERED TERMS OF DIRECTORS BUT IN PRACTICE THIS IS NOT HOW FPF HAS BEEN RUN.
